

Annex 2 - Transaction Report Attributes

This document is an annex to the document "MiFID II/MiFIR Reporting Description" of EEX AG and gives an overview of the data fields according to RTS 22.

- **RTS 22 ID** refers to the RTS 22 Field ID.
- **RTS 22 Reference** holds the name of the field as defined in RTS 22.
- **Schema Tag** is the tag name in the XML report.
- **Schema Structure** refers to the transaction XML structural section of which this field belongs to.
- **Format & Valid Values** provides the field format, pattern restrictions and lists of valid values
- **Draft Report Value** shows exemplary values with regard to the draft report generated by EEX AG.
- **Draft** indicates if the tag is used in the Draft report, if applicable.
- **Validation** indicates if the tag is validated after the upload of the Participant Report to the SFTP.
- **Mandatory** indicates if the tag is a mandatory field for reporting. Tags can be mandatory ("Y"), not mandatory ("N") or conditionally mandatory ("C"). For example providing the buyer ID is mandatory, but which format is a choice therefore the different variants of providing the buyer ID are all conditionally mandatory, meaning one of the tags needs to be provided.
